Q Baroness Jones of Whitchurch: Will the reuse and refill inquiry also cover the deposit return scheme (DRS)?

A Policy Connect: Yes, DRS will feature as an element as will extended producer responsibility.

Q Baroness Jones of Whitchurch: Given increasing importance of the sustainability of water use in the context of manufacturing, agriculture, construction etc. can the APSRG consider this?

A Policy Connect: Water use and sustainability is covered by Policy Connect elsewhere and Baroness Jones to be introduced to this work.

Q Lord Teverson: Is it worth taking a look at precious minerals and rare metals and their recovery to avoid over-reliance on mining? Also, a consideration to the renewables industry and batteries and their recyclability could be worthwhile.

Baroness Jones supports this suggestion.

A Policy Connect: Recoverability of metals will be put on the agenda.

Q office of Barry Sheerman: Harnessing energy from waste as a potential topic.

Lord Teverson points to recent work and focus on heat uptake from it.

A Policy Connect: Offer to connect Barry Sheerman with Policy Connect colleague focusing on energy from waste.

Baroness Jones of Whitchurch: Offer to connect with ethical fashion group in House of Lords and source speakers on the topic.

Lord Teverson: Waste crime as another topic to consider.
